

CALL FOR APPLICATIONS: CIACC SCHOLARSHIP

The Circle of Accounting of University of Ruhuna, is pleased to announce the call for applications for the "CiAcc" Scholarship. This scholarship program is dedicated to supporting students specializing in Accounting who are facing financial difficulties in pursuing their academic goals.

Eligibility Requirements

The scholarship will be available to full-time undergraduates enrolled at BBA in the Accounting degree program. Further, the following criteria is considered. Exhibit financial need, as determined through thoroughly evaluating the student's financial circumstances. This should be supported with an annual income certification from the Grama Niladhari and the Divisional Secretariat of the residential area.

- a. Provide a compelling personal statement highlighting their financial need.
- b. Must not be an accused or offender for any breach of laws and regulations of the university during the academic period.

Four 2000 Level undergraduates of Department of Accountancy are selected, and the selected undergraduates will receive the scholarship in Rs.2,500 worth five instalments per academic semester. This scholarship instalments are awarded during four specialized academic semesters except second semester 4000 Level.

How to Apply

Interested students must complete the CiAcc Scholarship Application Form, and submit it to the Department of Accountancy, Faculty of Management and Finance, University of Ruhuna on or before 11th November 2024. Ensure all required documents are attached to the application, including proof of financial need, and a personal statement explaining your financial situation and academic aspirations.

Selection Process

A dedicated scholarship committee will comprehensively review and evaluate all submitted applications based on the eligibility requirements and the applicant's academic qualifications, professional qualifications, extra-curricular involvement, and family financial records.

Important Notes

- The CiAcc Scholarship aims to provide financial assistance to deserving students, so please ensure that your application reflects your genuine financial situation.
- Scholarship recipients are expected to maintain satisfactory academic progress.
- We encourage eligible students to apply for the CiAcc Scholarship and take advantage of this opportunity to alleviate financial barriers to their education.
